- 1. OCCUPANCY:*** Applicant must be a current student for may semester, full summer or summer I to be eligible for summer interim housing assignment.
- 2. RESPONSIBILITY FOR PERSONAL PROPERTY:*** The University does not assume any legal obligation to pay for loss or damage to items of personal property.
- 3. LOCKOUTS DURING INTERIM:*** During the hours of 8 a.m. - 4:30 p.m., Monday-Friday, you may checkout a loaner key from the Office of Housing/Residence Life and Dining Services. After 4:30 p.m., weekends and holidays, you must contact the Office of Public Safety at 221-7786. Please be advised officers will only respond in cases of emergencies. The University and the Office of Housing/Residence Life and Dining Services will be closed May 26, 2008.
- 4. DINING SERVICES:*** Meal plans will not be available during interim period.
- 5. POLICIES AND PROCEDURES:*** Interim residents are expected to comply fully with all Residence Life policies and **procedures** and the APSU Student Code of Conduct. - 6. CANCELLATION:*** A written request must be submitted to the Office of Housing/Residence Life and Dining Services before the first day of the interim period in order to cancel your application for interim housing and not be charged interim fees. Failure to cancel your interim application before this deadline could result in improper check-out fees charged to your account.
