FEE DISCOUNTS FOR DEPENDENTS OF CERTIFIED PUBLIC SCHOOL TEACHERS OR STATE OF TENNESSEE EMPLOYEES

The State of Tennessee has approved a program enabling children under the age of 24 whose parent is employed as a full-time certified teacher in any public school in Tennessee or as a full-time employee of the State of Tennessee to receive a 25 percent discount on in-state maintenance fees.

Who is Eligible for the Program?

Children or dependents of full-time certified public school teachers in Tennessee or full-time employees of the State of Tennessee under the age of 24 are eligible for the discount. For purposes of this program, certified public school teachers are defined as teachers, supervisors, principals, superintendents and all other certified personnel. Full-time State employees must be scheduled to work 1,950 hours or more per year. Eligibility shall be determined on the first day of classes for each term. Qualified students must apply for admission by the published deadline and meet all APSU admission requirements in order to utilize this program.

Where Can This Program Be Used?

The discount program can be used at APSU or any other institution operated by the University of Tennessee or the Tennessee Board of Regents which offers courses of instruction beyond the high school level.

What Types of courses Can Be Taken?

Fee discounts are available for undergraduate credit courses. Eligible students may enroll in any number of courses up to and including full-time study.

How Do I Obtain the Fee Discount?

Complete the reverse side of this form and have the student personally present it as a part of his/her registration fee payment.
