III. Course Proposal

RDG 4020-change in course description to include "work with struggling readers" and to change "provisional admission" to Milestone II. Gary Stewart made the motion to approve the changes. Michele Butts seconded the motion and the motion carried.

IV. Curriculum Proposals

History Education-addition of three upper division World History courses to the recommended course list (HIST 3600, 3750, and 3840). Deletion of Psychology and Sociology endorsement from the major due to low student interest. Barbara Peterson made the motion to approve the changes. Linda Davis seconded and the motion carried.

MAED: Curriculum & Instruction-Special Education-replace EDUC 6500 with SPED 5806. The SPED course is specifically designed for Special Education Educators whereas the EDUC 6500 is not. Gary Stewart made the motion to approve the change. Anne Wall seconded the motion and the motion carried.

Music Education-Addition of MUS 4500, the deletion of EDUC 4160 and the title of "minor in Professional Education". The major will keep the required courses for licensure: EDUC 3070, 4440, 4080, SPED 3000, Clinical Teaching and Seminar. Jennifer Snyder made the motion to approve the changes. Jennifer Fillingim seconded the motion and the motion carried with Don Luck abstaining.

Health & Human Performance Teaching: Delete HHP 2010 from the program and add EDUC 3040. Marcy Maurer made the motion to accept the change. Anne Wall seconded the motion and the motion carried.

English Teaching Specialization-revision of course electives in linguistics and upper division electives. Addition of LING 4030, 4060, and 4600 to the required option in Linguistics.
