Committee Actions Overview

The University Curriculum Committee convened on November 10, 2025, and reviewed the following agenda items, which were unanimously approved. Below is a summary of each item for the Faculty Senate members.

Approval of Previous Meeting Minutes

- October 20, 2025, UCC Meeting Minutes: Minutes from the previous meeting were reviewed and approved without objection.

Consent Agenda Items

Course Number Updates

1. STAT 4470 – Data Visualization and Exploration:
 - Updated course number from STAT 4170 to 4470 for better alignment with course content.

Course Credit Hour Updates

2. CSDI 3000 – Guided Observations in Speech-Language Pathology:
 - Credit hours revised from 2 to 3 to reflect the increased instructional content.
3. AAST 3020 – Seminar in African American Studies:
 - Adjusted to a fixed 3-credit-hour course from a variable credit system (1-6).
4. CSCI 4900 – Special Problems in Computer Science:
 - Updated to be offered for variable hours (1-3 credits) and can be repeated up to three times.
5. DANC 1040 – World Dance:
 - The credit hours were changed from 2 to 3 to accommodate the enhanced course content.
6. UNIV 2100 – University Success:
 - Converted to variable credits (1-3) to allow flexibility for students.

Course Teaching Load Credit Implementation

7. POLS 4540 – Legislative Internship:
 - Teaching credit load adjusted to 3 credits per course to prevent overloads for instructors.

Course Title Updates

8. Multiple Courses: Renamed various courses for clarity and accuracy, including:
 - NURS 5902 – MSN Capstone: Updated from "Capstone" to "MSN Capstone."
 - ACCT 5100 – Advanced Financial Accounting: Changed to reflect current curriculum standards.

Course Description Updates

9. CSDI 3000 – Guided Observations in Speech-Language Pathology:
 - Description revised to require 25 hours of guided observation.
10. NURS 5902 – MSN Capstone:
 - New emphasis on integrating and applying nursing knowledge in practice.

Course Deletions

11. Multiple Courses:
 - A series of courses that are no longer necessary due to curriculum streamlining were approved for deletion, including several HIST and CSDI courses.

Course Prerequisite and Corequisite Updates

12. CSDI 3000:
 - New prerequisites established to enhance student readiness.
13. Various Other Courses:
 - Adjustments were made to ensure prerequisites align with course expectations.

Program CIP Code Changes

14. Data Science Certificate:
 - CIP code updated to align with industry standards following program restructuring.

New Course Implementations

15. COMM 3250 – Professional Communication Competencies:
 - A new course designed to develop essential professional communication skills.
