Minutes

Calling of the Roll Announcements

Banner is unable to accommodate the course prerequisites for COMM 3770, 4337, 4350, 4960, and
4970 which were approved at the February 10, 2020 UCC meeting. The department has been notified
that the "or Junior Standing" is unable to be utilized in conjunction with course requirements, and the
utilization of courses only as prerequisites have been approved by the Department Curriculum
Committee and Chair at this time.

Telaina reiterated that the courses are built in two separate places in Banner, that it is not possible to list them as either/or. She also advised against putting the courses in the Bulletin as either/or but said a statement could be added that special approval is needed from the Dean.

New Business

Academic Affairs

- Recently, Academic Affairs has received questions regarding the requirements for a minor. The 2019-2020 Undergraduate Bulletin indicates a minor should have a minimum of 18 credit hours and 6 credit hours of those 18 credit hours must be completed with upper division courses (3XXX 4XXX). The following questions are presented for UCC discussion:
 - o Should minor courses be allowed to double count with major courses?
 - What is the standard practice for this process within your college/department?
 - o Should there be a limit on the number of hours for double counting in minors and majors?

Dr. Coleman advised that Computer Science uses a chart of which majors and minors students can complete together. Both Dr. Maurer and Dr. Rennerfeldt advised that their departments have situations like this where the courses double-count but the hours do not. Dr. Rayburn advised for the Leadership Science minor that six hours of specified classes in other Social Science courses will count for both major and minor. Dr. Webb advised that Art majors cannot earn a minor in Art. Dr. Sullivan suggested that upper division courses should not be counted twice. Jasmine O'Brien gave an example of the Political Science major and

International Relations minor and advised all courses count twice. Dr. Brown thought this might work

better as a concentration and said it should be determined by the individual departments.

A question was raised by Leah Frazier regarding how the limitations affect financial aid. Telaina advised that these situations do not affect financial aid.

16. BSRT Radiologic Technology – concentration in General Radiologic Science

Implementation Fall 2021

• Adding a new concentration to assist students who are not eligible for admission into the professional program.

Dr. Lebkeucher advised that sometimes students cannot meet the requirements for admission to the professional programs due to the core prerequisites. The General Radiologic Science concentration completion would allow students to complete a degree program and potentially qualify for Vanderbilt University Medical Center's certificate program. A motion was made by Dr. Rennerfeldt and seconded by Dr. Coleman to approve the concentration. A vote was taken, the motion passes.

Undergraduate Course Revisions – Final approval required from Provost/VP Academic Affairs

19. EDUC 3040 – Instructional Technology

Implementation Fall 2021

 Updating prerequisite to align with state requirements and terminology change from milestone to transition II

Dr. Lambert advised this is a change in terminology from milestone to transition II. A motion was made by Dr. Rayburn and seconded by Dr. Webb to approve the change in terminology. A question was raised by Dr. Maurer if the implementation date could be moved from Fall 2021 to 2020. Telaina advised this would not be possible unless it was done before priority registration. A vote was taken, the motion passes.

Additional agenda item:

Dr. Brooks asked for an additional agenda item for the Committee's review. The Graduate Academic Council (GAC) participated in a discussion on dual-listed 5000-9000 courses. Dual listing is acceptable for courses that are only 1000 apart (such as dual listing 5XXX level and 6XXX level courses). If the courses are more than 1000 apart, a case-by-case review may be needed. Dr. Brooks made a motion to have this information added to the course numbering guidelines. The motion was seconded by Dr. Coleman. A vote was taken, the motion passes.

Announcement:

An announcement was made regarding the 2020-21 bulletin publication date. Departments will be allowed more time to review the draft bulletin and suggest edits. Telaina Wrigley advised she has sent

out a procedure manual and asked for Committee members to submit their feedback a.s.a.p. The new deadline is April 15.

The next meeting is scheduled for April 13. A determination will be made closer to the meeting date if the Committee will need a larger room and/or will conduct the meeting with an 800# again or a virtual option.
