1. Termination of Accelerated Masters Pathways Implementation Fall 2020
Dr. Chad Brooks, Dean of the College of Graduate Studies, explained the purpose of the Accelerated Masters

Pathways (AMP). These are not degree programs. The AMP allows undergraduate and graduate courses to be double-counted. This raises some concerns with SACSCOC Principles of Accreditation, the University needs to develop a different pedagogical approach in the future. In the meantime, the University will cease offering these pathways.

A committee member said that these are a good idea and other institutions offer them. The Provost agreed and indicated that in the future, we would need to implement these in a different manner.
