Provost Gandy asked each member to introduce themselves. The Vice Provost briefly explained the committee voting.

Academic Affairs:

1. Dual Listed Courses

- Only list 4000 level courses can be dual listed with 5000 level courses.
- Dual listing of courses must be approved through the University's curriculum approval process, using Curriculog

Provost explained his concerns about dual listing of 3000 level with 5000 level courses. He explained that generally speaking he does not support this. However there are some instances, such as orchestra, where students of all levels are in the orchestra together. The Provost did not ask for a vote, but asked for concerns and questions, and general support for the Provost's office to discourage dual listing of 3000 and 5000 level courses.

The Curriculum Coordinator and the Vice Provost also explained that the Office of Academic Affairs is reviewing the approval records of dual listed courses to make sure each has an approval on file.

2. Policy 2:064

- Updating the verbiage for instruction hours to meet with our current processes and the U.S Department of Education

The Vice Provost explained the purpose of the policy revisions. The committee members asked many questions about the revisions, including criteria for determining the amount and level of credit awarded, impact on zero-based credit hour courses, graduate level rigor, and relationship to teaching load credit. The Provost explained

that questions, such as graduate level rigor, can be examined during the upcoming credit hour review scheduled to be conducted this fall.

A committee member asked about the plan to obtain feedback from faculty. The Vice Provost explained that the proposed revisions will be presented to Faculty Senate for first reading at the September Faculty Senate Meeting.

Motion passed, unanimous vote.

4. MSLP Speech-Language Pathology

Implementation Fall 2021

- Creating a new graduate program in Speech-Language Pathology
- Assist students with developing the knowledge and skills to manage the care of individuals who have communication and swallowing disabilities.

Dr. Marcy Maurer, Chair of Health and Human Performance, explained the status of the proposal and the goal of launching the program in Fall 2021. A committee member asked how the program will be staffed. Dr. Maurer explained that the program currently has one qualified full-time temp faculty member, and Provost will make decisions regarding the hiring of additional faculty. The proposal contains information regarding the needs for additional faculty. Dean Brown explained that some of the MSLP faculty will also support the related undergraduate concentration.
