Old Business

The Health Care Management concentration within the BS Health and Human Performance recently had
a curricular modification approved. When attempting to build the course into Banner it was noticed that
the LDSP 3000, elective course, had been terminated by the department. Approval is needed to simply
remove this elective from the elective options in Health Care Management.

Jasmine O'Brien, Curriculum Coordinator, explained the oversight. Motion passed unanimously.

Dr. Allen Barger, Center for Teaching and Learning, explained the benefits of developing concentrations in BS General Studies. Specifying concentrations and courses within each concentration, would work better with DegreeWorks and would reduce the number of course substitutions currently being processed with BS General Studies students. One UCC committee member asked how the courses were identified. The committee member expressed concern that some of the courses are restricted to students in a specific major, such BSMLS Medical Laboratory Science (and BS General Studies students would not be allowed to take the courses). Dr. Barger explained that if a student dropped out of the BSMSL program, the student could use those MSL courses toward the completion of the BS General Studies program. The UCC committee member indicated his understanding and support of this idea. A typo on the Health side by side was noticed and corrected on 7.18.2019. The BIOL 2030/2031 should be 2300/2301.

Dr. Sienkiewicz explained the goal to offer a BM Music with a concentration in Music Therapy. She explained the value of music therapy and emphasized the goal of starting with an introduction course to increase student interest. This will allow time to build the program next year and hire a full-time faculty member. She explained that Vanderbilt University offers this program. Vanderbilt hired an additional faculty member three years after launching the program, due to the growth of the program. Motion passed unanimously.
