National Security Studies Major

Implementation Fall 2022

Updated the curriculum based on the external reviewer feedback. These updates include: making MATH 1530 (Elements of Statistics) a major requirement which satisfies General Education requirements, adding NSS 2001 (Introduction to National Security Studies) and NSS 4990 (Senior Capstone in National Security Studies) as required major courses, and CRJ 4860 (Internship) and CRJ 4900 (Directed Individual Study) to the guided electives.

1. Degree Components Guidelines

Implementation Summer 2021

• Updating the Degree Components Guidelines to include clarifying language for hour requirements, removal of the utilization for duplicate titles at the undergraduate and graduate level, updated the charts showcasing the break out of degree hours and sections required.

Jasmine O'Brien, Curriculum Coordinator, explained that the Degree Components Guidelines document was updated to include clarity in the upper division requirements. Additionally, the tables for the breakdown regarding degree hours was updated to ensure programs were able to comply with the structure without seeking exceptions. Some of these changes were based on programs seeking accreditation.

2. Policy 1:027 – General Education and Degree Requirements

• The proposed revisions to Policy 1:027 include changes to the courses permitted to satisfy the Humanities and/or Fine Arts requirements of the General Education requirements for associate and baccalaureate degrees and removal or update of some outdated language from the original Tennessee Board of Regents policy.

Jasmine O'Brien explained that the policy was updated in the Humanities section only, allowing a two-course sequence of Foreign Language courses to be utilized as a part of the Humanities and/or Fine Arts requirement.

3. General Education Bulletin Information

- Implementation Summer 2021
- Updating the bulletin to have a specific page for General Education to make it easier to locate
- Define the pillars and areas of the General Education Core

Kristen Sienkiewicz, Co-Chair of the General Education Standing Committee, explained that the General Education Standing Committee wants to add a special section to the Undergraduate Bulletin to allow this information to be more accessible and visible. These pages allow for clarity in the requirements as well as explain the definitions and expectations of each area.

4. COGS 5000 – Continued Enrollment

- Implementation Summer 2021
- This zero credit course allows students to remain enrolled at APSU while completing their graduate program requirements.

Dean Brooks, College of Graduate Studies, explained this course is needed so graduate students who are continuing to work on their Thesis or Research would be considered continuously enrolled and would maintain access to the library and other necessary buildings without violating any university rules or vendor contracts. This course is a zero credit hour course and students will incur no fees or tuition. Dean Brooks will serve as the instructor of record. A question was posed regarding whether this course would take the place of the 5991

courses and Dean Brooks indicated departments could still utilize the 5991 course if they wished.

Department of History and Philosophy – represented by Jordy Rocheleau

- 5. HIST 4092- Judaism in Jesus' Day: The 2nd Temple Period Implementation Fall 2022
 - This course provides an overview of Jewish history from the building of the second temple under the Persians to its destruction under the Romans. It covers the political, literary, and religious history of the Second Temple Period.

Jordy Rocheleau, Department of History and Philosophy, explained this course would cover the special interest area of Judaism at the time of Jesus and address a current gap in the program.

- 6. PHIL 3140 Special Topics in 19th, 20th, and 21st Century Philosophy Implementation Spring 2022
 - This course will explore a topic in 19th, 20th, or 21st Century Philosophy. Topics will vary.

Jordy Rocheleau explained there is an existing course that covers these topics in generality. This course allows for a specific area in the century to be studied in more depth.

7. LING 4041 – How Words Work

- Implementation Spring 2022
- This class is about morphology, the field of linguistics that examines how words are broken down into smaller, meaningful parts. Each part has its own history, sometimes with surprising cultural and geographic origins.
- 8. LING 4042 How Sounds Work

Implementation Fall 2022

• Ever wonder why a word like *sandwich* might be pronounced *samwich*, *sammich*, or *sangwich*? Phonology is the field of linguistics that answers those questions by looking at sound systems in

a scientific way.

9. LING 4700 – Linguistics Project

Implementation Spring 2022

• This course is designated as an independent study in linguistics. You may take this course, with instructor approval, to pursue your own investigation of linguistic subject matter.

Mercy Cannon, Chair of Languages and Literature, explained that these three courses will assist with increasing the diversity of the Linguistics minor and English majors can also complete these new courses. Two courses are in specific areas and one is an Independent Study.

10. NSS 1010 – Introduction to National Security Studies

Implementation Fall 2022

- This course introduces students to National Security Studies. Students completing this course will know the nature of the national security organizations and their responsibilities, be aware of the major strategic issues confronting the nation, and know the current national strategy for responding to national security threats.
- 11. NSS 4990 National Security Studies Capstone

Implementation Fall 2022

• National Security Studies Capstone provides engagement in a student-centered, content-related learning experience that serves as a summary and synthesis of courses in a student's undergraduate academic career. Students select an area of interest related to their academic studies and engage in an activity leading to a research project or applied project reflective of comprehensive knowledge gained in undergraduate studies and demonstrate their knowledge of the outcomes of the Bachelor of Science degree in National Security Studies.

Linked items 10 and 11.

Dean Brown presented the two proposals, explaining that the External Reviewer noted that the National Security Studies major, while interdisciplinary in nature, could utilize an Introduction course and a Capstone course. These courses add some individuality to the program by being NSS courses and help the department address the External Reviewer's suggestions.

Dean Hepner, College of Business, explained that a College of Business task force reviewed the Business Core and looked at other universities' Business core. The College of Business is proposing changes for all of the BBA majors. The proposals include the addition of BUS courses, removal of three one hour courses and updating the MATH course utilized in the General Education requirements. The MATH course was not submitted previously to allow the Department of Mathematics and Statistics adequate time to make needed adjustments in scheduling and faculty. These changes will enhance the quality for graduates.
