## **Department of Languages and Literature** – represented by Dr. Florian Gargaillo

#### **Undergraduate New Course**

**Implementation Fall 2025** 

Final approval required by the Provost

- 1. GREK 4999 Advanced Reading in Ancient Greek Authors
  - Selected advanced readings in Greek prose or poetry, to be determined by the instructor.
     Students will read substantial selections from authors such as Herodotus, Homer, Lysias, Plato, Euripides, and Sophocles.
- 2. LATN 4999 Advanced Readings in Latin Literature
  - Selected advanced readings in Latin prose or poetry, to be determined by the instructor. Students will read substantial selections from authors such as Caesar, Vergil, Livy, Cicero, and Ovid.

Dr. Florian Gargaillo presented the creation of two new courses. Currently only two classical literature courses which are special courses and these will assist with better showing the differences in rigor and also assist with students being able to take the course multiple times and receive financial aid.

  - Adding the additional hour of EDUC 2100 (Foundations of Education)into the program hour calculation.

Dr. Kevin Tanner presented that the BS HIST is being changed to be consistant with the BA one additional course and removing the minor requirement. For the History Education concentration updating to insure the capstone course is being taught by education and the EDUC 2100 hours update.

7. Healthcare Administration

• This 9-hour online program is designed for professionals who would like to earn a graduate credential in healthcare administration. Students will learn essential industry concepts through targeted courses in Management of Healthcare Organizations and Systems, Law, Policy, and Advocacy, Conflict Management for Healthcare Environments, Healthcare Economic Policy, Healthcare Quality Outcomes and Improvements, Financial Planning and Accounting in Healthcare, and Health Informatics. All credits earned seamlessly transfer to our Master of Healthcare Administration (MHA) degree program, giving students a flexible pathway to advance their education.

#### 8. Physical Education

- For those interested in teaching Physical Education in K-12 environments, this program allows enrollees to complete the required coursework to add the PE endorsement to their existing license.
- This certificate will also help individuals to take the necessary PE Praxis Exam. Passing this exam with the certificate coursework will allow teachers to add the K-12 PE endorsement to their teaching license.

Dr. Alex Adams presented items 6 and 8 Physical Education certificate which will assist those who are wishing to get an endorsement to teach in K-12 settings. One requirement is 12 hours of coursework in PE.

Dr. Tim Leszczak new certificate in Healthcare Administration. One mandatory course offered in the Fall and then electives and complete in Spring or fall. This could also be a good certificate for students who have elective hours within their graduate program.

He also presented on the Sports, Wellness, and Coaching concentration which is the new name for the current Sport and Wellness Specialist concentration. Additionally, changing the required courses in the concentration so students have more course options for online courses. Students have to take 8 of 10 courses. Then have recommended courses that they take as elective hours, would take ten of these courses and still have electives within the concentration as well.

The Community and Organizational Certificate was slightly different in that they are lowering the required hours to 9 from 12.

# **Department of Political Science and Public Management**-represented by Dr. John Phillips

#### **Undergraduate New Course**

- 12. PM 3009 Bioterrorism, Preparedness, Surveillance, and Mitigation
  - This course equips students with the knowledge and skills to understand, prevent, and respond to bioterrorism threats. Through an interdisciplinary approach, students will explore concepts from public health, epidemiology, emergency management, and biodefense. The course is designed to prepare students to address these challenges within regional, national, and global contexts.

#### 15. Public Policy Minor

• Public Policy minors will acquire deep knowledge of governmental processes, master the tools of policy analysis used in the field, and develop a thorough understanding of how public policies are formulated, implemented, and evaluated.

The program is structured around a required course in American government (POLS 2010) and a two-course sequence in public policy (POLS 2040 and PM 3235). Students can then choose 9 hours from a variety of electives to acquire further skills and knowledge relevant to the policy areas that they wish to specialize in, including but not limited to: economic policy, social policy, urban development, health care, family policy, crime and punishment, judicial policy, and foreign policy.

Students with a minor in public policy prepare for the following jobs and career paths: policy analyst, policy researcher, legislative analyst, public affairs specialist, government relations officer, lobbyist, and policy analyst. They can work for legislators, government agencies, think tanks, non-profit and advocacy groups, IGOs, INGOs, and universities.

Dr. John Phillips presented all four proposals. Item number 12, a new course they are wanting to make part of the curriculum. One reason for the creation of this course is that Michael Kasitz is no longer working with the University and so needed to create a course in an area where there was existing faculty expertise. In the past had deleted many PM courses which were no longer taught due to faculty no longer being part of the University. This course is going to be an elective in the major, minor and Emergency Management minor.

Item number 13 and 14 – previously changed the number of PM 3000 to PM 2000 so it could be taught through Dual Enrollment. This course then no longer counted in the major electives as those were upper division and are adding this back so it will be 2000 or 3000 - 4999.

Item number 15 – Last semester looking around state to see what other Universities were offering and saw that we had a lot of Public Policy courses but no where for them to really go. So this minor was created so existing courses could be utilized toward a program. This is a little more career driven than other minors and assist with jobs if they are interested in jobs on capital hill and other jobs in this arena.

Matthew Kilpatrick presented that the BUS 0900 is being proposed as an Academic Support Course specifically for BUS students who are experiencing difficulties in the classroom. This will allow students to register for a specific time to receive assistance with coursework.
