- 1. LIBR 2001 Empowering Information Seekers in the Digital Age
 - This course is designed to introduce students to strategies and skills needed to become savvy information consumers and creators by exploring the multifaceted nature of information in the digital age. Students will develop a deeper understanding of how to identify, evaluate, and ethically use information from a wide range of sources, including databases, scholarly journals, websites, and social media platforms. This course will also explore the ethical and legal considerations related to information use, including copyright, plagiarism, and privacy issues. There are no prerequisites for this course, and all majors are encouraged to enroll.

Jennifer Harris presented – the library has never had a for credit course. Have previously done one shot courses where they offer things the length of time of a course and go to courses. So are now proposing to do these as for credit courses and adding the necessary competencies. This will assist with developing critical thinking skills and also have a way through a number of assignments to see how they are evaluating and synthesizing information. A good Segway for any student going into any major.

- 3. HON 2110 Critical Thinking
 - This course presents the principles of critical thinking and formal argumentation such as understanding how to frame questions, how to discuss various branches of philosophical inquiry, exploration of logical fallacies, deductive and inductive arguments, and the application of such arguments in a paper.

Trying to teach on top of content in HON 1040 course but doesn't work because of how much content is in other HON courses. This is largely designed to make up for what students aren't getting at high school level for structuring paper. Providing them that part and broader skill of critical thinking.

- 4. HON 2520 Community Communication and Servant Leadership
 - An Honors Service Learning course to enhance public speaking skills while exploring leadership interests for community service. Students will apply public speaking principles and techniques with emphasis on informative and persuasive speeches. The class combines the speech communication process with use of outlining, research, visual aids, and audience analysis.

This will put students together with a local NGO and help them to learn to work up a plan and to work on connections with community and put into practice critical thinking skills and give them opportunity to reinforce theory on communication that they are getting in the classroom.

- 5. HON 4400 Interdisciplinary Studies III
 - Continuation of applying the principles of interdisciplinary study to a broad range of topics at an advanced level.

Extension of the freshman course 1045 because students have given great feedback on what they were getting and wanting the opportunity to do more of that. This course will give them that opportunity.

- 6. HON 4510 Honors Internship
 - Students will complete an internship either on or off campus.

Partly connected to the Washington Center and partly connected to students who came and asked about internships because they had opportunity but was outside of their major so they did not have the means to take the internship so this will allow them to do this.

Dlynn Williams asked if this was proposed as variable credit? Yes, it was.
