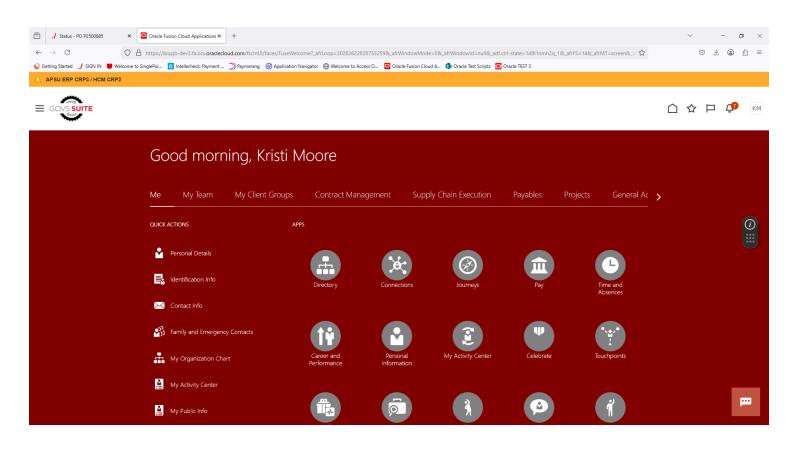

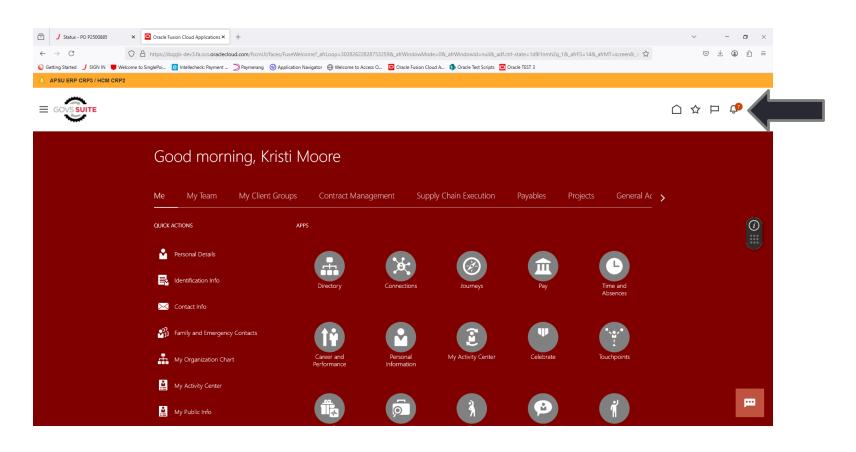


After logging in, you should see the Govs Suite Home Page displayed.



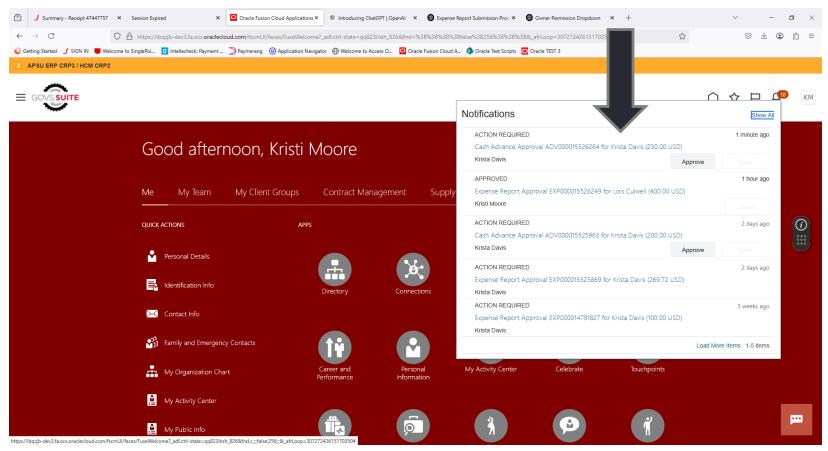

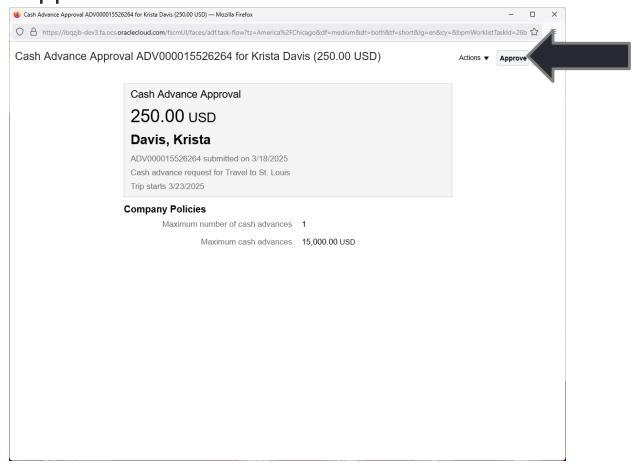


Click on the cash advance request that you would like to view. It will open in a separate window.



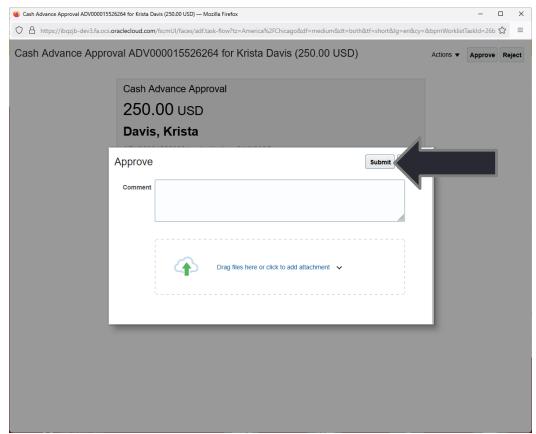


If you agree with the Cash Advance request and would like to approve it, click the Approve button.



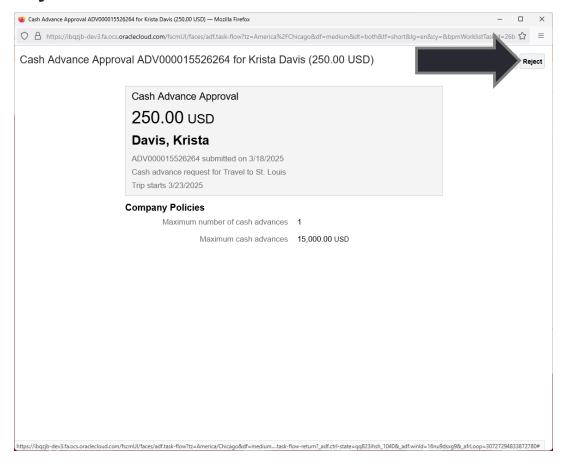

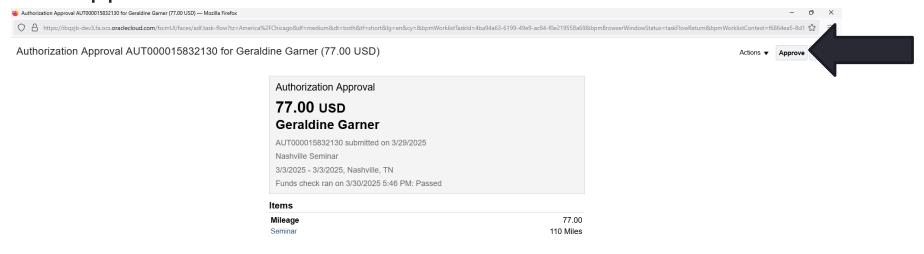


Click on the authorization approval request that you would like to view. It will open in a separate window.



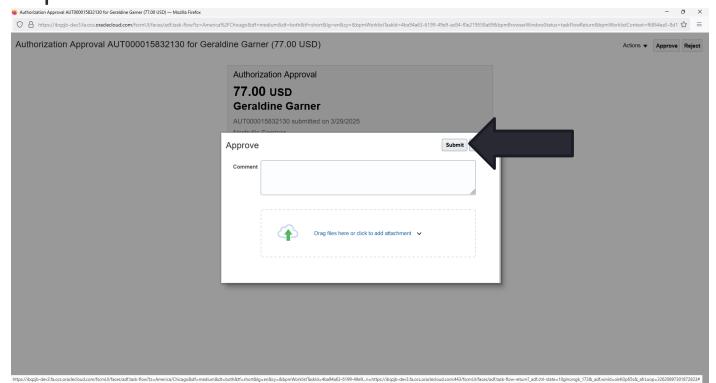

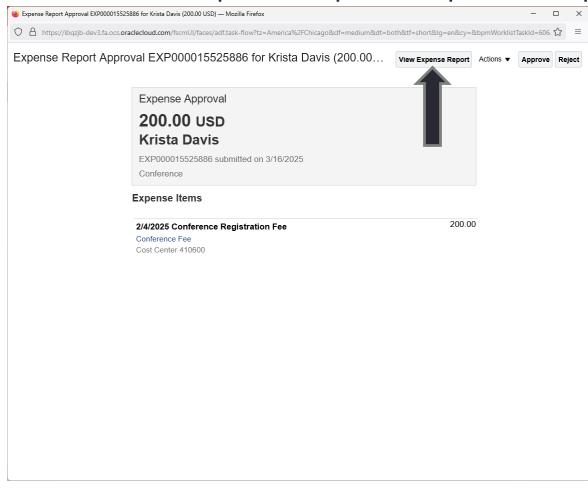


Click on the expense report that you would like to view. It will open in a separate window.



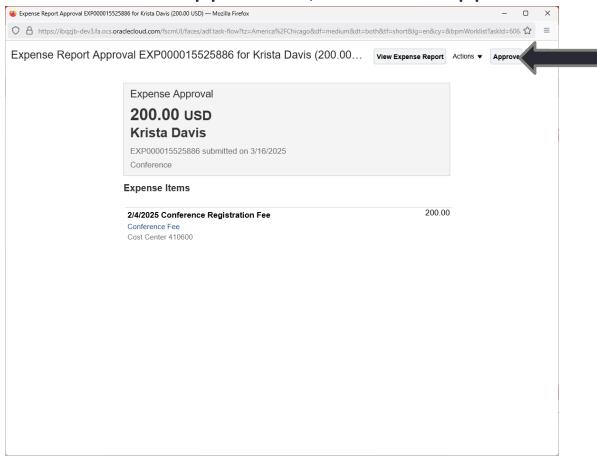


Click on View Expense Report to open the report you are approving or rejecting.



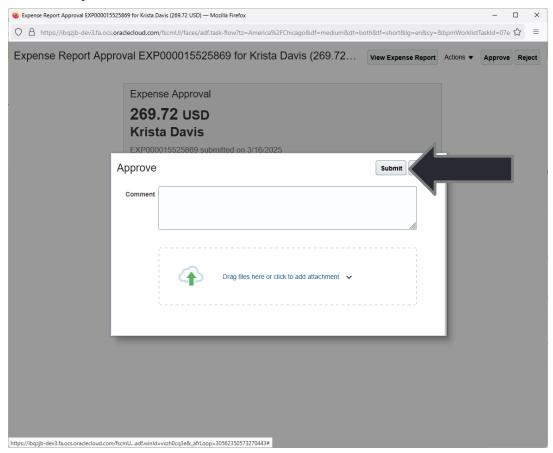

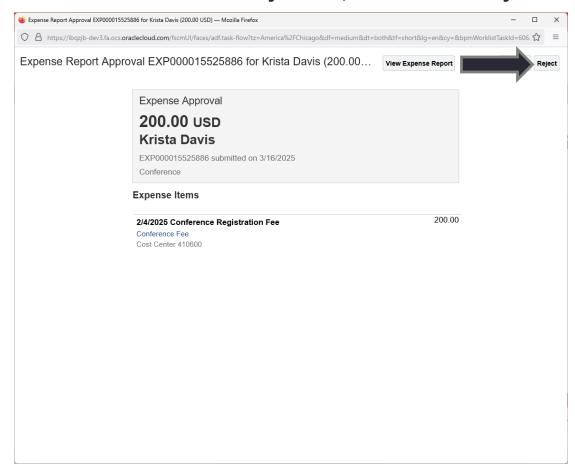
