Students in MHA 5420 will review their Leadership Philosophy initially composed in MHA 5020 (see SLO Assessment Method #1). This second assessment method will occur in Spring 2023 and will involve students revisiting their Leadership Philosophy and composing a new or revised statement to incorporate informal and collective leadership practices. Students will be assessed using a revised, but similar, rubric for the original statement. The focus of this 2nd assessment method will be on students progression, ability to incorporate additional leadership development theories into their statements and synthesize, in writing, a new comprehensive statement. Collection will occur in MHA 5420, Spring 2023 by Dr. Melissa Kates. Rubrics for both assessments are in development but will be in place and available by summer 2022.

Students will be presented 4 questions on the second (final) exam that will ask them to correctly interpret laws, regulations, in relation to quality outcomes. Students will also be given acronyms of regulatory bodies of which they will be asked as to which they represent. This area will consist of 3 to 4 questions in the exam.

At least 80% of the students will correctly answer at least 3 out of 4 (75%) of the identified exam questions.
