

## Affidavit of Support and Financial Statement International F-1 Students

You must demonstrate that you will have the funds to cover your expenses for your first academic year (9 months) at Austin Peay State University. Students who plan to stay in the United States through the summer will need additional funds. **This form must be submitted to be considered for admission.** 

Your Form I-20, which you will use to apply for a visa, <u>will not</u> be issued until you are admitted to the University. This form is valid for <u>six months</u> from the date of signature. Unsigned forms will not be accepted.

Remember that you will not be authorized to work off campus when computing your expenses.

Add \$5,000 per academic year for your spouse and \$3,500 for each child if you want them added to your I-20. Please submit any dependents' passports with your application. Spouses of F-1 visa holders are not permitted to work under any circumstances.

You may need this documentation to prove to the United States Consular Operations that you have sufficient funds. We suggest, therefore, that you make copies of all documents for this purpose.
