Decisions of the committee will be reviewed by the Provost and Vice-President of Academic and Student Affairs only if incorrect procedures were employed. **An appeal for removal of suspension must clearly stipulate in detail the facts of extraordinary circumstance and include supportive documentation that warrant a review of the suspension.**
