All programs accredited by the Council on Social Work Education's (CSWE) Commission on Accreditation (COA) are required to measure and report student learning outcomes. All students are assessed using a minimum of two measures on their mastery of the nine competencies that comprise the Educational Policy and Accreditation Standards (EPAS) and any additional competencies programs may choose to add. These holistic competencies reflect the dimensions (knowledge, values, skills, and cognitive & affective processes) of social work practice that all social workers are expected to master during their professional training.

Programs determine a percentage-based benchmark for each competency and determine an outcome-measure benchmark (minimum score) for each measure. The competency benchmark (which can differ for each competency) represents the minimum percent of students the program expects to have achieved the outcome measure benchmarks in both/all measures for each of the nine competencies. The program then determines the percentage of students that attained each outcome measure (e.g., minimum score or higher), and aggregates the percentages for both/all measures together to obtain the percentage of students demonstrating competence inclusive of two (2) or more measures. The result of aggregating both/all outcome measure percentages provides the percentage of students achieving the competency benchmark. An aggregated percentage at or above the competency benchmark is considered achievement of that competency. If the program has more than one program option, the program must report data for each program option, and also an aggregate of all program options combined to determine an overall percentage of students across all program options achieving the competency benchmark.

Criteria for Benchmarks

The following narrative provides descriptions of how it is determined that students' performance meets the benchmarks for generalist competencies and advanced generalist (specialized) competencies. This information is also summarized in column 7 of the Assessment Plan Table.

Determination that Students' Performance Meets Generalist Competency Benchmarks

(1) Measurement One-Foundation Practicum I Learning Contract. The following narrative describes how it is determined that the students' performance meets the benchmark for Measurement One generalist level practice. Each field instructor rates their foundation MSW student intern(s) on the behaviors associated with each of the nine competencies at the midterm point and at the end of the term using rating the respective rating scales (located on page 80 and page 91, Vol. 3). Ratings for students are made using a 5-point scale: 5 = professional level of activity equivalent to employee, 4 = competent level activity, with indirect supervision, 3 = meets expectations, with direct supervision, 2 = beginning level activity only, and 1 = attempted but failed to engage in this task. The benchmark for Measurement One generalist level practice is that 85% of foundation students will score 4.0 or higher. A final score of 3.0 indicates that the student has met the basic expectation for the competency, while a score of 4.0 reflects mastery of the competency. A score below a 3.0 demonstrates that the student has not mastered the competency. Competencies assessed in this measurement are based on student interactions with clients in real or simulated situations in their foundation practicum.

The midterm evaluation is used to provide the student with feedback halfway through the semester, and to serve as a preventative measure to warn students of any concerns while there is still time to rectify them; it is not used as a measure of competency. Both the field instructor and the faculty field liaison assigned to monitor each student's field practicum use the data from the midterm evaluation to process students' strengths and needs in order to create plans for continued improvement and growth related to each core competency and the respective multiple dimensions associated with each competency. The final evaluation is used to provide students with formal feedback on their development of each competency (including the respective associated multiple dimensions), and is also used to inform their field practicum grade. To obtain a score for each competency on Measurement One, the field instructor rates a student on their performance of each competency while taking into consideration the multiple dimensions comprised by each competency. These scores are then entered into D2L, where they are stored for determination of the percentage of students achieving the benchmark across the program.

(2) Measurement Two-Key Generalist Course Assignment. The following narrative describes how it is determined that students' performance meets the benchmark for Measurement Two assessment of generalist level practice. Designated MSW faculty assess foundation MSW students' reflections on their progress towards each of the nine competencies using the grading scale associated with the identified key generalist course assignments. Students' scores and feedback on this assessment measure are used to provide students with formal feedback on their development of each competency, inducing respective associated multiple dimensions. Each assignment is scored using a percentage (e.g., a score of 18/20 = 90%). The scores for each student are reviewed to determine if the meet the set benchmark (80%). It is anticipated that 85% of students will score an 80% or higher on these key foundation course assignments. In the APSU MSW program, a grade of 80% on an assignment is equivalent to a "B" in the university grading system. These scores are then entered into D2L, where they are stored for determination of the percentage of students achieving the benchmark across the program.

Determination that Students' Performance Meets Advanced Generalist (Specialized) Competency Benchmarks

(1) Assessment of Measurement One-Concentration Practicum II Learning Contract. The following narrative describes how it is determined that the students' performance meets the benchmark for Measurement One advanced (specialized) level practice. Each field instructor rates their concentration MSW student intern(s) on the behaviors associated with each of the nine competencies at the midterm point and at the end of the term using rating the respective rating scales (located on page 80 and page 91). Ratings for students are made using a 5-point scale: 5 = advanced professional level of activity equivalent to advanced employee, 4 = competent advanced practice level activity, with indirect supervision, 3 = meets expectations, with direct supervision, 2 = beginning level advanced activity only, and 1 = attempted but failed to engage in this task. The benchmark for Measurement One advanced level practice is that 85% of concentration students will score 4.0 or higher. A final score of 3.0 indicates that the student has met the basic expectation for the competency, while a score of 4.0 reflects mastery of the competency. A score below a 3.0 demonstrates that the student has not mastered the competency. Competencies assessed in this measurement are based on student interactions with clients in real or simulated situations in their concentration practicum, where students are expected to demonstrate master's level performance in the form of advanced generalist practice.

The midterm evaluation is used to provide the student with feedback halfway through the semester, and to serve as a preventative measure to warn students of any concerns while there is still time to rectify them; it is not used as a measure of competency. Both the field instructor and the faculty field liaison assigned to monitor each student's field practicum use the data from the midterm evaluation to process students' strengths and needs in order to create plans for continued improvement and growth related to each core competency and the respective multiple dimensions associated with each competency. The final evaluation is used to provide students with formal feedback on their development of each competency (including the respective associated multiple dimensions), and is also used to inform their field practicum grade. To obtain a score for each competency on Measurement One, the field instructor rates a student on their performance of each competency while taking into consideration the multiple dimensions comprised by each competency. These scores are then entered into D2L, where they are stored for determination of the percentage of students achieving the benchmark across the program.

(2) Assessment of Measurement Two-Key Advanced Generalist Course Assignment. The following narrative describes how it is determined that students' performance meets the benchmark for Measurement Two assessment of advanced generalist level practice. Designated MSW faculty assess concentration MSW students' reflections on their progress towards each of the nine competencies using the grading scale associated with the identified key advanced generalist course assignments. Students' scores and feedback on this assessment measure are used to provide students with formal feedback on their advanced development of each competency, inducing respective associated multiple dimensions at an advanced level (that is, beyond a general practice level understanding). Each assignment is scored using a percentage (e.g., a score of 18/20 = 90%). The scores for each student are reviewed to determine if the meet the set benchmark (80%). It is anticipated that 85% of students will score an 80% or higher on these key foundation course assignments. In the APSU MSW program, a grade of 80% on an assignment is equivalent to a "B" in the university grading system. These scores are then entered into D2L, where they are stored for determination of the percentage of students achieving the benchmark across the program.
