Volunteer Income Tax Assistance

Each year, United Way volunteers help thousands of low-income and at-risk taxpayers prepare their taxes through the VITA free tax prep program. In 2025, we're offering in-person VITA tax prep at the Clarksville-Montgomery County Library as well as virtual VITA.

Raise Your Hand partners with administrators and teachers to implement tutoring sessions in participating schools. Our volunteer tutors work in the classroom after school helping teachers with first-through eighth-grade students who are struggling with reading and math. Teachers and volunteers partner to listen to and coach each child to success. Participation is completely free for students and includes snacks and transportation home...
