**Citing Artwork in a Museum or on a Museum Website**

**Basic Format:** Artist(s) last name, Initial(s). (Year). *Title of artwork* [Description of medium: Oil on canvas, Photograph, Sculpture, etc.]. Museum or Collection, City, State/Province, Country. URL

Citing Artwork With No Title

**Basic Format:** Artist Last Name, First Initial. (Year). [Description of artwork]. Museum Name, Location. URL

**Example**

van Gogh, V. (1889). *The starry night* [Painting]. The Museum of Modern Art, New York, NY, United States. [https://www.moma.org/learn/moma\\_learning/vincent-van-gogh-the-starry-night-1889/](https://www.moma.org/learn/moma_learning/vincent-van-gogh-the-starry-night-1889/)

**In-Text Citations**

- **Parenthetical Format:** (Artist Last Name, Year)
  - **Example:** (van Gogh, 1889)
- **Narrative citation:** Artist Last Name (Year)
  - **Example:** van Gogh (1889)

**Citing An Art Exhibition**

- If curator(s) are listed, they go in the author position.
- If no curator is listed, the exhibition title moves to the author position.

**Citing An Exhibition With No Named Curator**

**Basic Format:** Title of exhibition [Exhibition]. (Year or Year–Year). Museum Name, City, State/Country. URL

**Example**

*Design for eternity: Architectural models from the ancient Americas* [Exhibition]. (2015–2016).

The Met Fifth Avenue, New York, NY, United States.

**In-Text Citations**

- **Parenthetical Format:** (Title of exhibition, Year)
  - **Example:** (Design for eternity, 2015–2016)
- **Narrative citation:** Title of exhibition (Year)
  - **Example:** Design for eternity (2015–2016)

**Citing An Exhibition With Curator**

**Basic Format:** Curator Last Name, First Initial., & Curator Last Name, First Initial. (Year or Year–Year). *Title of exhibition* [Exhibition]. Museum Name, City, Country. URL

**Example**

Martinez, J.-L., & Douar, F. (2018–2019). *Archaeology goes graphic* [Exhibition]. The Louvre, Paris, France, <https://www.louvre.fr/en/expositions/archaeology-goes-graphic>

**In-Text Citations**

- **Parenthetical Format:** (Curator Last Name and Curator Last Name, Year)
  - **Example:** (Martinez and Douar, 2018–2019)
- **Narrative citation:** Curator Last Name and Curator Last Name (Year)
  - **Example:** Martinez and Douar (2018–2019)

**Citing An Informational Museum Plaque**

- Use a description in square brackets in place of a title
- Use the plaque's date (if available)
- Use (n.d.) if no date
- Do not use the artwork's original creation date

**Basic Format:** [Description of plaque]. (Year or n.d.). Museum Name, City, State/Country.

**Example**

[Plaque with background information about American Gothic]. (n.d.). Art Institute of Chicago, Chicago, IL, United States.

**In-Text Citations**

- **Parenthetical Format:** ([Shortened plaque description], Year)
  - **Example:** ([Plaque with background information about American Gothic], n.d.)
- **Narrative citation:** [Shortened plaque description] (Year)
  - **Example:** [Plaque with background information about American Gothic] (n.d.)

**Basic Format:** [Description of plaque]. (Year or n.d.). Museum Name, City, State/Country.

**In-Text Citations**

- **Parenthetical Format:** ([Shortened plaque description], Year)

**In-Text Citations**

- **Narrative Citation Format:** [Plaque with background information about American Gothic]
